Noah Canada and APF Canada are partnering to recruit up to four Canadian university students for its summer internship program at Noah Holdings' Hong Kong office. The internship will begin in mid-late May 2018 and will include a 12-week program of work





and learning. The program will accelerate fellows' experience, develop leadership capabilities, and provide broad exposure to the wealth and asset management industry in China. Through rotational assignments in various roles throughout the wealth management, asset management, global product platform, and internet finance arms within Noah, as well as training, fellows will acquire a diverse set of skills, an understanding of the business, and will be able to leverage developing capacities into practical and strategic results.

The Asia Pacific Foundation of Canada (APF Canada) <u>has been a strong advocate</u> for the importance of young Canadians getting work experience in Asia. Through this program, students will receive valuable work and cultural experience in Hong Kong, along with a C\$7,000 award to cover travel and living costs. In return, the students will become 'ambassadors' and advocates for the importance to other Canadian youth of getting first-hand experience in Asia. They will do this through speaking engagements and/or writing for the APF Canada blog about their own experiences.

- Proficiency with personal computers as well as pertinent software programs
- Values and integrity
- Aptitude for and interest in the wealth and asset management industry
- Language: English; Mandarin is an asset but not compulsory





Role Expectations

- Interns will be expected to develop the core wealth and asset management and leadership knowledge and skills. They will be challenged throughout the program and will have the guidance and encouragement of rotation managers, colleagues, buddies, mentors and the program manager.
- Proactively support others through direct and indirect actions beyond and including activities particular to this role, program team initiatives, and the associated position rotations.
- Live and represent the Noah brand; exemplify brand attributes.
- Participate in training programs to enhance product knowledge.
- Understanding and adhere to policies and procedures, and meet all required mandatory training requirements. Understand and adhere to local and global compliance.
