

**Second Roundtable for the Track 1.5 Process to Review and Update the
CPTPP Chapter 14 on Electronic Commerce**

February 12, 2025

READ OUT

On February 12th, Canada's National Committee of Pacific Economic Cooperation (CANCPEC), and the Australian Pacific Economic Cooperation Committee (AusPECC), co-hosted a virtual roundtable discussion to continue the Track 1.5 process to review and update the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) Chapter 14 on electronic commerce (e-commerce). This marked the second gathering of more than 13 digital trade experts from 10 APEC economies and highlighted the significance of the CPTPP at a time of heightened global economic tensions.

Through the Track 1.5 process, the group aims to provide an ambitious set of recommendations to policymakers as part of the CPTPP's formal review process under Australia's 2025 Chairmanship of the Commission.

To ensure the CPTPP remains an agreement of the highest possible standard amid rapidly evolving digital advancements, participating experts discussed the need to build upon leading digital rules of existing regional agreements. There was an emphasis on raising the ambition of the CPTPP, and the potential for the agreement to drive digital development in the Indo-Pacific region, particularly with new opportunities surrounding data innovation and artificial intelligence (AI).

The main takeaways from the discussion include:

1. The significance of the CPTPP is critical as ever in today's global landscape.
2. Creative and ambitious recommendations are encouraged given the opportunities the CPTPP offers at this time. However, recommendations must be adaptable to diverse regulatory approaches of CPTPP economies.
3. A high level of ambition is encouraged which incorporates frameworks to support innovation and AI governance, with a view to attracting AI developments and sharing AI benefits more equitably across the region.

The experts will meet again in April 2025 to finalize recommendations which will be presented to the 2025 CPTPP Commission under Australia's leadership.
